Dear Parent(s)/Guardian(s):

You have nominated your child to determine eligibility for Early Kindergarten or Grade 1 Entry. The process as outlined in the Cumberland School Committee Policy JECB-Early Entry to Kindergarten and First Grade, requires your consent to conduct evaluations to determine your child's eligibility for early admittance.

The evidence collected from the administration of evaluations will be reviewed and you will be notified of the outcome for eligibility for early admittance to kindergarten or first grade.

Evaluations that will be conducted for Early Admittance to **Kindergarten or First Grade**:

1. **School Readiness Assessment**: This includes two parts of assessment completed concurrently. A. Parent(s)/Guardian(s) will complete a standardized rating scale that measures social/emotional development and B. Students will participate in an assessment that evaluates foundational academic concepts necessary for kindergarten or first grade. Students must score in the 90%ile to move onto the next evaluation.
2. **Weschler Pre-School and Primary Scale of Intelligence (WPPSI)**. Those students who score in at least the 80%ile will qualify for early admission to kindergarten.
