BE IT RESOLVED BY THE CUMBERLAND SCHOOL DEPARTMENT OF CUMBERLAND AS FOLLOWS:

WHEREAS: The Cumberland School Department for emergency purposes as well as its daily operations needs the ability to communicate with town residents;

WHEREAS: Reliance Communications, Inc. can provide these needed services at less cost than the current system being used;


NOW THEREFORE, BE IT RESOLVED BY THE CUMBERLAND SCHOOL COMMITTEE OF THE TOWN OF CUMBERLAND RHODE ISLAND AFTER DISCUSSION & VOTE AS FOLLOWS:

SECTION 1: The Cumberland School Committee hereby empowers the Superintendent of Schools to execute a contract with Reliance Communications, Inc. of Santa Cruz, CA in an amount not to exceed fifteen thousand, five hundred and ten dollars (\$15,510) which equates to \$1.65 per student per year on an agreed upon student count of 4,700 students. The price will not fluctuate if actual student enrollment is different.

SECTION 2: THIS RESOLUTION SHALL BECOME EFFECTIVE IMMEDIATELY UPON ITS PASSAGE BY THE CUMBERLAND SCHOOL COMMITTEE


